From Pitt to Peel 1783-1846

- 1 Assess the reasons why the Whigs were unable to challenge Pitt's domination of British politics in the period from 1783 to 1801. [50]
- 2 'Peel's reforms at the Home Office were the most liberal reforms of the Tory governments of 1822–30.' How far do you agree? [50]
- 3 'Government in the national rather than party interest.' How far do you agree with this view of Peel's ministry of 1841–46? [50]

Liberals and Conservatives 1846-95

- 4 Assess the reasons why there was so much support for liberalism in the period from 1846 to 1868. **[50]**
- 5 Assess the reasons why Disraeli and the Conservatives lost the 1868 election. [50]
- 6 'The Liberal ministry of 1880–85 was more successful than that of 1892–95.' How far do you agree? [50]

Foreign and Imperial Policies 1856–1914

- 7 'The aims of British foreign policy in the Balkans changed considerably in the period from 1856 to 1902.' How far do you agree? [50]
- 8 Assess the reasons why Britain was involved in Africa in the period from 1868 to 1902. [50]
- **9** Assess the reasons why relations with Russia improved in the period after 1902. **[50]**

Domestic Issues 1918-51

- 10 How important was the First World War in the decline of the Liberal party by 1924? [50]
- 11 Assess the reasons for the high rate of unemployment in Britain in the 1930s. [50]
- **12** Assess the social and economic impact of the Second World War on Britain. [50]
